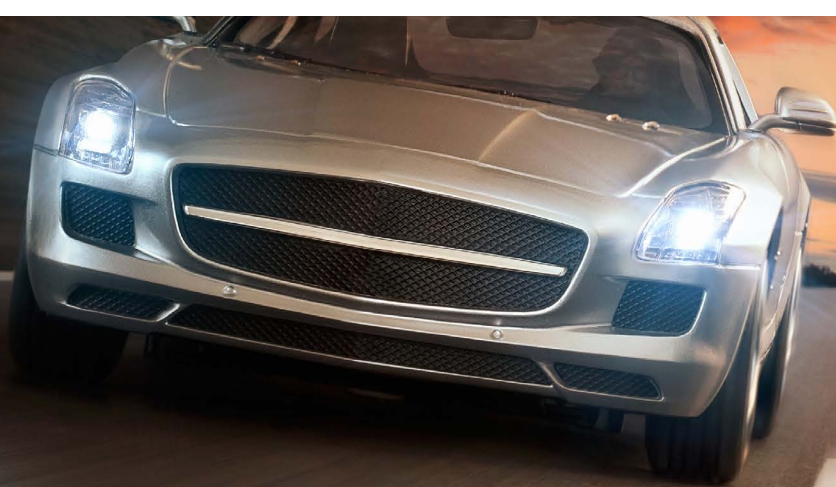

WHITE GLOVE 24/7 EMERGENCY ROADSIDE ASSISTANCE

Unlike traditional roadside services, we can accommodate specific ultralux towing and transportation needs. Emergency roadside assistance is available on a "sign & drive" basis, nationwide, 24 hours a day, 365 days a year, up to a maximum benefit of \$250 per incident. Towing, Jumpstart, Flat Tire Change (with Inflated Spare), and Lockout assistance are included in this benefit. A maximum of three (3) incidents per 12 months.

RENTAL CAR

In the event your vehicle is in need of an overnight repair, you may be reimbursed for up to ten (10) days, at \$150 per day (\$1,500 max), for rental car reimbursement expenses you incur.

TRAVEL BREAKDOWN

In the event of a covered mechanical breakdown and you are in excess of 100 miles from your primary residence, you may be reimbursed up to \$300 per day (\$900 max per occurrence), for meals and lodging expenses you incur.

LUXURY KEY FOB

TIRE & WHEEL BENEFIT

Participation in track day events other than competitive events will not void the service contract, unless the vehicle is hired to do so on a commercial basis.
