How the V Points Program Works

- To enroll, complete the form on the reverse side. Please print legibly. Print the completed form, sign and date it and fax it to 210.579.1497
 - V Point enrollment forms are available at www.gopip.com. If your dealership already participates in CalTex programs, you can enroll online at any time.
 - Within 2 business days you will receive your number via email. To earn points, you must record your number in the upper left corner of valid warranty registrations. You will also receive a stamp and ink-pad to make the process easier. Accrued points are applied on the 20th of each month.
- ▶ ***To earn points, all valid warranty registrations must have your PIP number printed or stamped. All unawarded points expire 12 months after the date of product sale.***
- **Personal Identity and Security**
Any information you submit will be used solely for the purpose of enrollment. Omissions of mandatory fields will delay enrollment processing.
